INTRODUCTION

Last year's Tour proved popular and received very good feedback from those that took part. So we are pleased to hold another tour this year. We aim to attract trial's competitors and road cars alike (including classic cars by invitation) and to that end we have maintained a low entry fee. Two routes will be on offer: a short one for those who need to travel back earlier in the day on Sunday; and a longer one for those with more time on their hands. As with last year, the Tour will start from Ashover Village Hall: it will travel through our lovely Derbyshire countryside - dotted with suitable refreshment stops - and finish back at Ashover where there is a choice of local hostelries. We hope to see a good turnout of members both old and new.

SUPPLEMENTARY REGULATIONS

'Held under the General Regulations, of the Motor Sports Association (incorporating the provisions of the International Sporting Code of the FIA) and these Supplementary Regulations.'

1. **Announcement**. The Vintage Sports-Car Club will organise a Touring Assembly on Sunday 8 March 2015, starting and finishing at Village Hall, Ashover, Derbyshire S45 0BA. (MR 119/ 352632).

2. **Regulations**. The meeting will be held under the General Regulations of the Motor Sports Association (incorporating the provisions of the International Sporting Code of the FIA) insofar as they apply to Touring Assemblies, these Supplementary Regulations and any written instructions that the organising club may issue for this event. Event insurance will be provided as part of the entry fee by means of a Certificate of Exemption (number TBA) that will be obtained from the Motor Sports Association.

3. Officials. The Clerk of the Course is John Higgs (Mob: 07887 420831).

4. **Vehicle eligibility**. The event is open to cars (including 3-wheel cars) made before I January 1941 and driven by members of the Organising Club. Cars do not need to have a VSCC 'Buff Form'. The maximum entry will be 60 cars.

5. **Entering the Event**. Entries open on the publication of these regulations and close on Monday 23 February. The entry fee is £16.00 per car. Cheques to be made payable to VSCC Ltd. Please send a completed and signed entry form to the VSCC at The Old Post Office, West Street, Chipping Norton, Oxfordshire, OX7 5EL HQ. Alternatively entries can be made online at www.vscc.co.uk. Entrants should declare any specific preference of longer or shorter route (see paragraph 8 below).

6. **The Road Book**. Full Joining Instructions will be issued approximately one week prior to the event. A road book will be issued on the day, providing route instructions, information about local places of interest and refreshment stops.

7. **Registration**. On the day, registration will be from 9.00am with participants able to leave as soon as they have been registered and scrutineered. Crews should report to the organisers with all relevant documents as described here. Scrutineering will be limited to ensuring the vehicle is eligible (N.B. MOTs are no longer required by law by cars registered Pre-1960). Cars must comply with current legislation covering Road Fund Licence, including the changes that came into effect from I October 2014. It is the Competitors' responsibility to ensure their vehicles comply with the Road Traffic Act(s) and cars must be insured for the public highway. All crew members must 'Sign-on'. Anyone travelling in the car must be able to be properly seated in the car. It is recommended that all cars carry a serviceable fire extinguisher.

8. **Route**. Two routes will be available: a long route; and a short route for participants who may need to leave earlier. Both routes will be available in the Route Book but participants must declare at registration what route they intend to take. The longer route will be approximately 55 miles: the shorter one will be approximately 35 miles so allowing a lunchtime finish.

9. Driving Standards. It is mandatory that great care is taken near horses or joining main roads. Anyone driving in a dangerous manner may be reported to the Club Secretary. All drivers are reminded that they should abstain from the consumption of alcohol or drugs and that the Road Traffic Act should be adhered to at all times. Please take great care on the narrow roads, and if you are followed by another vehicle, VSCC or not, pull over and let them by. Convoys of cars can spoil everyone's day.

10. **Finish**. At the finish all drivers must report to the organisers at Ashover Village Hall to sign a Damage Declaration Form. All crews are encouraged to return to the start/finish by no later than 4.30pm. If, for any reason, you are unable to return to the venue at the end of the day, please telephone Clerk of the Course John Higgs on his mobile 07887 420831 and ensure that your Damage Declaration is completed, signed and sent back to the VSCC office as soon as possible after the event.

As the Parent/Guardian/Guarantor 'I confirm that I have acquainted myself with the MSA General Regulations, agree to pay any appropriate charges and fees pursuant to those Regulations (to include any appendices thereto) and hereby agree to be bound by those Regulations and submit myself without reserve to the consequences resulting form those Regulations (and any subsequent alteration thereof). Further, I agree to pay as liquidated damages any fines imposed upon me up to the maxima set out in Part 3, Appendix I.'
