

#### 5. Non Starts

Any competitor unable to start should ring the Secretary of the Meeting at the Club Office on 01608 644777 ext 4 up to 5pm on Thursday 7 April, thereafter the Secretary's mobile phone on 07860 204501, which also has a message facility.

#### 6. Arrival at Event and Registration Procedures

Please proceed directly to Scrutineering which will take place on a first come first served basis, starting from 0815hrs onwards. After passing Scrutineering please take your process card from the Scrutineers and proceed to Signing-On.

When you reach Signing-On please ensure you bring all of your passengers with you, as they will all need to sign on. Please note that for passengers under the age of 18 you will need to complete a consent form (enclosed), allowing them to take part in the event. You will then be issued with your Competition Numbers and any final instructions. Please note that all trailers and support vehicles must be parked in the field at the front of the house. Your Scorecard will be handed out at 0915hrs.

#### 7. Scrutineering

The Scrutineer will be looking around the car, checking general safety, and particularly checking the following items

- a. Fire extinguishers must be firmly mounted within the car, but easily accessible by the driver. i.e. Minimum standard AFFF 1.75 litres. Please note also 2 x 1 litre extinguishers are acceptable.
- b. Fuel Leaks there should be none
- c. Wheels and Tyres If different wheels and tyres are being used for the trial these must be available for inspection by the scrutineers on request. Security bolts and / or self tapping screws for securing tyres to rims are specifically banned. All tyre treads must be road legal.
- d. There must be a throttle return spring attached to the throttle spindle of each carburettor.
- e. Your steering wheel must be marked with tape at the top of the straight ahead position.
- f. Competitors not carrying a pre-attached tow rope must indicate their preferred point of attachment by marking it in red or yellow.
- g. There may be a roller type differential test at one of the hills, failure of this test may exclude you from the event.
- h. A minimum tyre pressure rule will be applied: 7 psi. for all classes. Random checks will be made, offside rear will be checked first. You will be asked if your pressures are correctly adjusted prior to climbing a hill, if yes, pressure will be checked, and if found to be below the minimum requirement a penalty point of 25 marks will be applied. If no, then you will asked to adjust, then the check as above will be applied. The pressure check will be done using the Club's digital gauges.
- i. MSA Compliant Spill Kits (N.B. homemade kits are not acceptable, see Clause 13)
- j. Child Seats are fitted for all children under the age of 12 or under the height of 1.35m in accordance with Clause 14

Please bring the VSCC Laminated Passport for the car entered (Buff Form) as it may be inspected by a VSCC eligibility scrutineer.

#### 8. Running of the Event

Hills will be open on Saturday 9 April between 0915hrs and 1630hrs, morning hills from 0915hrs – 1230hrs and afternoon hills from 1400hrs – 1630hrs. The marshals are authorised to take their well-deserved lunch from 1230hrs.

Please remember that failure to start at the 'designated hill' (marked on your scorecard) first will incur a penalty of 25 points. The start marshal on the section will sign your scorecard to indicate that you have complied with this instruction.

Please note that the hills both morning and afternoon have been arranged into groups which you must do in sequence. If your start hill is in Group 2 then you will do the hills in Groups 3 and 4 before you do Group 1 hills.

It is the competitors responsibility to have the score entered on the scorecard and signed by the start or finish marshal, or the marshal nearest to his/her point of failure/success; the marshal will enter the score on the card. The entrant must drive throughout the competitive part of the trial and the passenger seat alongside the driver must be occupied at all times by a passenger aged not less than 12. No passenger under the age of 12 may be carried in an open car. No dogs may be carried on the observed sections. The number of passengers may not be varied from section to section nor may any ballast.

A Stop and restart has been set-up on Hills 8 & I I. Competitors will be briefed by the marshal at the start. Drive up the section to stop astride the stop line but with the front wheel hubs behind the second line (where present). Then at the signal from the marshal, and with no rolling back or other manoeuvring, restart and continue to the end of the section.

As your route may touch or cross Public Paths and Rights of Way, competitors must exercise caution and reduce their speed accordingly near other path users. Be especially careful near horses. Slow down, stop and switch off your engine if necessary. In this respect follow marshals instructions on the section. This is particularly relevant following the Scottish Government's recent report about safety of stage rallies. The implications of this applies to trials too – spectator safety is paramount.

Walking the hill will be allowed on all sections.

Marshals have been given authority to remove dangerous rocks, tree trunks and branches which may become exposed during the course of the event.

If you have to retire during the event, please let the marshals know who will transmit the message via the radio network to the Clerk of the Course and the Secretary. If you break down on the public road please ask other competitors to let the marshals know.

#### 9. Marking

The method of recording scores will be as follows: wherever you stop on the hill, the marshal nearest to that point will mark the card with the score and initial it. Front wheel hub marking will be used and competitors will be credited with the appropriate marks for the part of the section reached by the centre of the front wheels. A car will be deemed to have stopped when the un-driven wheels cease to revolve, or when it fails to leave a start or restart, or when it touches a marker of any kind.

To avoid any misunderstanding MSA Rule T6.4 is quoted in full;

6.4 A competitor will also be considered to have failed to negotiate an observed section non-stop if:

6.4.1 Any part of their vehicle or its occupants touch a marker

6.4.2 All four wheels are positioned outside the boundary of the course at the same time. The boundary is represented by a straight line drawn from course marker to course marker along the direction of the course.

6.4.3 The point of failure will be considered to be that at which any marker is first struck, or the point at which the boundary of the course is first crossed by all wheels of the competing vehicle. (e.g. the competitor strikes marker 6 but receives a 5 mark)

6.4.4 Should this point of failure coincide with the division between two sub-sections, the marks lost will be those appropriate to failure in whichever of the two sub-sections provides the greater penalty.

Remember - It is the competitor's responsibility to ensure the scorecard is signed by the marshal.

#### II. Alcohol

Competitors are reminded that in accordance with MSA Regulations the consumption of alcohol whilst competing is not permitted. <u>May we also remind competitors of</u> the new, more stringent, drink driving regulations in Scotland where even one pint may take you over the legal limit.

#### 12. Sections and Instructions

- 12.1 Beware sheep and walkers. Drive slowly. It is unavoidable that you will meet competing cars on some of the roads between sections. We, and you, are reminded by the police that the Road Traffic Act applies at all times in all places.
- 12.2 The hills have been deliberately grouped in either pairs of hills or groups of three hills
- 12.3 Pairing and grouping has been done to reduce queuing.
- 12.4 Following your start hill, competitors must complete all other hills in that Group before moving on to the next group in sequence order i.e. from Group 1 to Group 2 to Group 3 to Group 4. If Hill No 9 is your morning start hill you must complete the other hills in that Group before moving to Hill No 1 and moving through groups sequentially.
- 12.6 The same approach applies to the afternoon hills of completing the all hills in a Group before moving to the next group in the sequence i.e. from Group 6 to Group 7. If Hill No 11 is your afternoon start hill, competitors must exit it and proceed to Hill No 12 and then Hill No 10. If Hill No 12 is your afternoon start hill, competitors must exit it and proceed to Hill No 10. After completing Hill Nos 10, 11 and in Group 5 competitors must do Group 6 hills.

This year there are 10 morning hills and 8 afternoon hills listed on the scorecard. Two hills from each session will be dropped as we set the sections out and these hills will be deleted from your scorecard. The remaining sections should be attempted in the order set out above. It is possible a group of 3 may become a pair of hills, or a pair become a single hill.

All entry points and hill locations will be signed with hill numbers as will the means of going from one to another and the exit routes

Please remember to sign the Damage Declaration on the reverse of your Scorecard

#### 13 MSA Compliant Spill Kits

All competitors should note the following extract published by the MSA with regards to acceptable spill kits and that this will be reinforced by all trials scrutineers in accordance with the below guidelines.

The MSA wishes to remind competitors of the definition of an Environmental Spill Kit, as stated in section (B) of the Competitors' and Officials Yearbook: "For use in managing spills of automotive fluids, lubricating oils, fluids, gasoline, coolant additives, hydraulic oil etc...".

Some competitors are reported to have produced bags of sawdust, nappies and other similar products, claiming them to be Spill Kits. Such items do not meet the regulatory requirement. Purpose-made kits that meet the regulations are available from most motor sport equipment retailers and many specialist suppliers. They are available from, amongst others:

#### 14 Child Restraints

All Competitors are reminded of the following requirement regarding children on trials.

Open Cars or Front Seat of Saloons - minimum age 12 years old

Back Seat of Saloons – MSA Bluebook 2014 T4.1.6 - The rear seats of a saloon can be occupied by the number of people for whom it was designed. Passengers who occupy the rear seats of the vehicle must not be aged less than 2 years of age, any child under 12 years of age or 135cm in height must be seated using an approved 'child restraint'.

Please note the installation and suitability of the Child Restraints, Seats and all associated Mountings are the sole responsibility of the Entrant.

All Competitors should notes that this regulation will be strictly reinforced at scrutineering.
