



COMPETITORS' INSTRUCTIONS

I. Introduction

Many thanks for entering this year's Autumn Rally. You will find enclosed all of the information you require at this stage to compete on this event, including the entry list and route hand out times.

Please Note – Scrutineering and Signing-on will close 30 minutes before your individual (Morning) start time. Failure to have signed-on before this time may result in refusal to start the event.

3. Event Locations

Scrutineering, Signing-on, Start, and Finish are all located in the car park at The George and Dragon (174/566588).

The Halfway halt, for lunch and time recovery, is located at Beech Hill Village Hall, Reading, (175/699643).

The Official Notice Board will be located at the Start/Finish venue.

4. Champagne (Class 4)

For the less experienced crews in Class 4, support will be available to enable any queries regarding the navigation or format of the event to be answered.

7. Trailers

Please note the use of trailers to and from the event is permitted, however the use of trailers during the event is not permitted. There is parking for all non-competing cars and trailers at the start/finish venue.

8. Arrival at Event & Registration Procedures

Scrutineering will take place as you enter the Car Park, please remember to display a valid tax disc for the car entered and also bring your Laminated Buff Passport in you are competing in Classes I-3. Once you have passed Scrutineering you will be given a Process Card, please take this card to Signing-on inside. It is the competitor's responsibility to present the car in a fully roadworthy condition and properly equipped to take part in this event. Competitors are reminded of the following MSA Blue Book extracts:

H.32.1.5. (ROADWORTHYNESS) An entrant shall, before the event, satisfy himself as to the eligibility and safety of the vehicle and safety equipment and the competence of its driver.

H.32.1.6. (ROADWORTHYNESS) An entrant shall furthermore ensure that a vehicle is maintained in an eligible and safe condition throughout the event or meeting.

H32.1.7. (ROADWORTHYNESS) The act of presenting a vehicle and safety equipment for official scrutiny shall be deemed a declaration of its fitness and eligibility for the event and an acceptance of the consequences of such a declaration not being valid.

At Signing-on both you and your Navigator(s) must sign-on. Non-member Navigators are required to complete the form at the end of these Instructions and hand it in to the Signing-on team. You will then be issued with Final Instructions, including average speeds, black spots, conventions, etc.) and your competition numbers. Please fix your competition numbers to your car where the Marshals will be able to read them as you approach/depart a Time Control (i.e. nearside of the vehicle). If you have competed on a VSCC Rally in 2013 please bring your rally plate with you!

9. Map Editions & Navigators Equipment

Please ensure you bring with you the following equipment:

- Ordnance Survey Landranger Map 175 edition C3 or C4
- Romer
- Basic Pencil Case including pencils and eraser
- Warm clothing?
- NB. A map extract from Map 174/185 will be provided to cover the section of the route not on Map 175.

Competitors are reminded that the use or evidence of fitment of post-1940 computer or calculating machines or Smart Phone used to measure distances or average speeds in any form are forbidden and will result in instant disqualification. The use of Halda Speedpilots and Tripmasters or any other similar equipment is specifically banned. Competitors are further reminded that digital stopwatches, clocks and all other readout/display devices are not permitted to be attached to the car in any way, failure to comply with this regulation may result in exclusion.

Petro

Petrol is available near the Start just north of Kingsclere on the A339 – see Mileage Check Map. There is a garage not far from the Lunch halt at 175/714664.

13. Route Instructions

All Competitors will be given the same basic route instructions, although Class 4 entrants (Champagne Class) will have additional/simplified instructions. Route instructions for the first half will be issued from the Signing-on desk and the second half issued from the Village Hall at the Lunch stop. Individual times for route collection vary so please see the detailed schedule at Signing-on.

14. Average Speeds

The average Speeds used on this event will be as follows:

Speed Category I (Fast) = between 21-26 mph

Speed Category 2 (Slow) = between 20-24 mph

15. Timing

Timing will be by marshals' hand held synchronised clocks. There will be a master clock available at the start to enable you to synchronise your own watch Scheduled Timing will be used. The time recorded will be the time that the car stops at the control. Competitors early or late at a control should aim to be an equal amount early or late of time at the next control, for which no further penalty will be applied. Should you lose further time or make up time you will be penalised at the next time control.

Time Controls will open 15 minutes before car I is due and close 30 minutes after the due time of the last car.

16. Halfway Halt

The Halfway Halt will last approximately 90 minutes, however this includes allowance for full time recovery. This means that if you have dropped time in the first half, you are allowed to recover the time lost (but not the penalties applied) before you start the second half, with the field re-starting in the original order once again.

17. Insurance

Individual Third Party Car Insurance

The Club has applied to Lockton for a Blanket Cover Note under the Motor Sports Road Traffic Scheme. This will provide Competitors who need to use the Scheme with the Third Party Cover necessary to meet RTA requirements on the Road Sections of the Event. The basic rate for the Event will be £22.28. New applicants wishing to use the Scheme must be able to comply with all points of the Lockton Declaration:

- Over 21 and Held a Full Licence for at least 6 months.
- Not more than I fault accident in the last 3 years.
- No more than maximum of 6 speeding points on licence.
- No physical or mental disabilities.
- No other material facts.

If you are able to comply with all the points above simply sign-on the Signing-on Form and pay the premium to obtain Insurance under this scheme – No Letter of Acceptance will be issued. If you are unable to comply with any of the above points you may be able to get cover but you must complete a Declaration Form which is available from the VSCC office (apply to the Secretary of the Meeting) and forward direct to Lockton prior to the Event to allow sufficient time for Letter of Acceptance to be issued. Faxed copies are acceptable.

18. Food & Drink

As detailed in the Supplementary Regulations; a buffet lunch will be available at £6 per head payable at signing-on - tickets will be issued.

19. Safety

The correct rally route is reasonably hazard free, but there are some areas that could be difficult to pass. It is impossible to judge the level of use by other road users, and so that our sport should not cause offence, we have to stress the importance of care to others, be they motor vehicles, agricultural equipment, horses, cyclists, pedestrians, local property owners or even fellow competitors. Competitors are asked to take particular care on narrow sections of road.

20. Passing

In the event of a faster car catching a slower competitor it is expected that the slower car will pull over as soon as possible to enable the faster car to pass as he may well be running at a higher average speed or is trying to regain time after a mistake. This is considered to be sporting behavior. This also applies to members of the public who should not be inconvenienced.

21. Public Relations

Considerable time and effort has been spent on PR for the rally and gaining a favorable welcome from the local people. Please do not jeopardise the good name of the VSCC in particular, and motor sport in general, by driving / acting in a manner likely to bring the Club into disrepute - we want to return in the future.

As a Competitor of the event you are automatically covered under the Governing Body's (MSA) Insurance Scheme in respect of public liability and personal accident. 

The Directors regard this as an introduction of the candidate by the undersigned and, subject to any demur by the Stewards of the event, hereby resolve that the candidate is admitted as a member of the Club at the commencement of the event for a period of the balance of the current calendar year and is inscribed in the register of the company's members.
- **4.** The Directors may levy any subscription or entrance fee in respect of short-term membership as they see fit. As a result the recipient of this category of membership will not be entitled to receive or benefit from any Club publications and/or other services that are offered to fully paid-up Club members.
