

Supplementary Regulations

- 1. The Vintage Sports Car Club will organise a Clubman's Permit Navigation Rally on 13 October 2013, based at Prestigne, Radnorshire (137/309649)
- 2. The meeting will be governed by the General Regulations of The Motor Sports Association (incorporating the provisions of the International Sporting Code of the FIA), these Supplementary Regulations and any written instructions that the organising club may issue for the event.

- 3. The route will be approximately 80 miles long using mainly coloured roads with the addition of a few miles of 'white' roads.
- 4. O.S. Landranger 1:50,000 Map 148, Edition B2 will be required.
- 5. The event is only open to all fully elected members of the organising Club, who have paid their 2013 subscription. Membership for the remainder of the calendar year is available at signing on for non-member navigators only. This membership is restricted as detailed in the Committee's Resolution of 16 May 2001. All drivers must be able to produce a valid club membership card.
- 6. The programme of the meeting will be;

Saturday 12 October

From 0700hrs Scatter Rally commences from individual locations
1100hrs – 1400hrs Scatter Rally Sign Off at Radnorshire Arms, Presteigne

Sunday 13 October

0800hrs Scrutineering & Signing On Open. Any competitor whose car has not signed on 30 minutes before their start time may be excluded.

0916hrs Team Entries Close

0931hrs Car I starts

1300hrs Car I due to arrive at finish

7. Scatter Rally – All competing cars must complete a road mileage of a minimum of 100 miles on the morning of Saturday 12 October 2013 before starting the rally on the following day. Competitors start in their own time after 0700hrs, and must, driving under their own power arrive at the Radnorshire Arms in Presteigne by 1300hrs, where they will be issued with a card which confirms they have completed the Scatter Rally successfully. Each competitor must pass through at least one Filter Point (details will be published in Competitors Instructions). The mileage requirement for the car is mandatory, it is not mandatory for the crew.

If you are marshalling on the Trial on Saturday, you are exempt from completing this Scatter Rally, but will be required to ask your Hill Chief to sign a card to prove that you marshalled. This card will need to be produced at Signing On for the Rally on Sunday morning in order to avoid incurring a penalty. Please note only one crew member is required to marshal in order to avoid accruing penalties.

Should you fail to complete the Scatter Rally or marshal you will incur a $15\,\mathrm{mark}$ penalty.

8. The Event will consist of four Classes as follows;

Class Number	Class Name	Plotting Time	Eligibility	
Class I	Expert	10 Mins	Open to all crews	
Class 2	Semi-Expert	20 Mins	Open to any crew where neither member has won a First Class award in a Semi-Expert (or equivalent) class or any award in an Expert (or equivalent) class on a VSCC rally in the previous two years, other than a team or marque award.	
Class 3	Novice	30 Mins	Open to any crew where neither member has won any award on a VSCC rally (excepting Class 4) in the previous three years, other than a team or marque award.	
Class 4	Champagne	30 Mins	Open to any crew. This Class is particularly aimed at beginners and newcomers, and they will receive the same instructions as other Classes, but with additional information. Class 4 will run the lower average speed, but will still be a Rally and not a Tour. There are no restrictions to entrants, any pre-war car may be used (so no need for a Buff Form) and there are no classificat awards in this class.	

9. The Event will consist of two average speed categories

Category No	Category Name	Average Speed	Eligibility
1	SCI	Will not exceed 26 mph	All other vintage and PVT cars
2	2 SC2 Will not exceed 23 mph		Cars entered in Classes I and 2 defined as Edwardian and Vintage Light Cars and all 2 wheel braked cars. All cars in Classes 3 & 4.

The Organisers reserve the right to re-classify entries and Speed Categories at their discretion.

- 10. All Classes will have the same basic instructions featuring techniques, as explained 'Finding Your Way', and differentiated by different plotting times. Class 4 (Champagne Class) will receive more straightforward instructions to the other Classes. Apart from a 'romer', pencils and eraser, no additional navigational instruments will be required.
- 11. Awards will be presented as follows:

The Talylin Trophy to the driver of the winning car.

A Bottle of Champagne to the winner of the Champagne Class

First, Second and Third Class awards based on performance within Class to driver and VSCC member navigators, counting towards end of year 'Best in Class' Awards.

Most Meritorious Performance - at the Organisers' discretion

Team Award to the three-car team with the best aggregate total, subject to a minimum of three teams entering - Champagne Class entrants are not eligible.

Teams of three cars may be nominated on the event entry form. Alternatively, team entries will be accepted at signing-on, up to 15 minutes before the first car starts. Only one Expert Class entrant is allowed per team. Each entrant may be in only one team. The team entry fee (payable only at signing-on) is £6.00.

Competitors entered in the Expert, Semi-Expert and Novice class will be eligible to accrue points towards the annual aggregate Rally Driver and Navigator Awards.

12. Expert, Semi-Expert and Novice Class cars must comply with the VSCC's Eligibility of Cars (2007), and have an Eligibility 2000 Document for the car entered lodged with the VSCC office before the entry will be accepted.

The Champagne Class is open to any pre-war car, with no requirement for an Eligibility Document to be filed.

All vehicles must comply with MSA Technical Regulations, must display a current tax disc and must be insured for 'Rally Use'. Carrying a securely mounted serviceable fire extinguisher is recommended. NB: The VSCC do not allow powder extinguishers, Halon/BCF types, as these are not allowed in the U.K.

- 13. The Entry List opens on publication of these Regulations and closes on 30 September 2013. The entry fee is £52. Each entry must be made on an official entry form or on-line and be accompanied by the appropriate fee. The team entry fee is £6 payable at the start.
- 14. The Secretary of the meeting to whom all entries must be sent is;

- 15. The maximum entry for the meeting is 75, the minimum is 25. Entries will be selected at the Organiser's discretion should the event be oversubscribed. Entries will be acknowledged (D16.1) by return and the entry fee may be refunded if the entry is cancelled before the closing date or if the event is cancelled.
- 16. Officials:

A list of Judges of Fact will be available from the Secretary of the Meeting upon request.

- 17. Provisional results will be published as soon as possible after the event. A copy of the results will be sent by post or email within 7 days of the event. (D26.1.2)
- 18. Competitors will be issued with rally plates, competition numbers and preliminary rally information at signing on. If you have already been issued with a Rally Plate for 2013 then please bring this with you.
- 19. Competitors will be identified by numbers provided by the organisers. These must be fixed to the front and rear of the car before the start and removed at the finish or on retirement from the event. (R6.1)
- 20. Car Number I will start at 093 lhrs with the rest following at I minute intervals. Your start time is calculated by adding your start number in minutes to 0930hrs. E.g. Car 29 will start at 0959hrs. Competitors will be required to make up lateness at the restart after halfway. (R12.6)
- 21. Marking and Penalties will be as M.S.A. General Regulations R13 except as modified below (items in brackets refer to MSA Competitors & Officials Yearbook Section R, Chart 13 reference):

- 22. All other General Regulations of the MSA apply as written, except for the following, which are modified
 - a) GII Driving Standards Observers will be appointed as Judges of Fact.
 - b) R5.4.3 Only the entrant may drive during the competition.
 - c) R10.4.5 Average Speeds for Speed Category I will not exceed 26 mph. Average Speeds for Speed Category 2 will not exceed 23 mph.
 - d) RII. Manned controls will open 15 minutes before the due time of car 1 and close 31 minutes after the due time of the last car.
 - e) R12.2.1 & R12.2.2 Scheduled Timing will be used. The time recorded will be the time that the car stops at the control. Competitors early or late at a control may be an equal amount early or late at a succeeding control without further time penalty.
 - f) R12.8.3 Competitors will be timed to the previous whole minute by the Marshals' official time pieces. (A clock will be on display at the start to enable you to set your watch to 'Rally Time'.)
 - g) R11.3 Controls and route checks will be established on the route. The position of these may not be disclosed in advance. Checks will be either manned points (Passage Controls), or unmanned (Route Checks) which will consist of Route Boards bearing code letters which must be copied exactly onto your time card, in the correct place, to avoid penalty.
 - h) R15.2.2 Ties will be decided by the 'furthest cleanest' method, should this fail to resolve the tie the older car will win.
- 23. Competitors' Instructions will be emailed or posted approximately 10 days before the event and posted on the Club's website for members to read. These Instructions will include an entry list by Class and Speed Category entered. Competitors wishing to change Class or Speed Category must notify the Secretary of the Meeting at the Club offices (01608 644777 ext 4) no later than 5pm on the Monday before the event. Any changes requested after this time will be at the discretion of the Steward.
- 24. All competing cars must display a valid tax disc, and be insured for the public highway. Insurance cover must include 'Rally Use'. Should you not have 'Rally Use' covered in your policy, the Club has applied to Lockton for a Blanket Cover Note under the Motor Sports Road Traffic Scheme. This will provide Competitors who need to use the Scheme with the Third Party Cover necessary to meet RTA requirements on the Road Sections of the Event. The basic rate for the Event will be £tbc, please speak to the Secretary of the Meeting at signing on to take out this policy. New applicants wishing to use the Scheme must be able to comply with all points of the Lockton Declaration:-
 - Over 21 and Held a Full Driving license for at least 6 months.
 - Not more than I fault accident in the last 3 years.
 - No more than maximum of 6 speeding points on license.
 - No physical or mental disabilities.
 - No other material facts.

If you are able to comply with all the points above simply sign on the Signing On form and pay the premium to obtain Insurance under this scheme – No Letter of Acceptance will be issued. If you are unable to comply with any of the above points you may be able to get cover but you must complete a Declaration Form which is available from the VSCC office (apply to the Secretary of the Meeting) and forward direct to Lockton prior to the event to allow sufficient time for Letter of Acceptance to be issued. Faxed copies are acceptable.

- 25. There will be no penalty for bringing your car to the event on a trailer. Space will be provided for parking of trailers, tow cars and tender cars at the start / finish venue.
- 26. 'Finding Your Way'. If you would like a copy of this introduction to rally navigation and timing by Dick Patten & Robert Ellis please enclose a 9 x 4 SAE with your entry form and request a copy.
- 27. The event will count towards the Club's annual trophies.
- 28. Loitering is defined as deliberately attempting to gain a time advantage by driving unduly slowly, or stopping, within direct line of sight along the road preceding the Control (other than to obey traffic regulations/road conditions). Penalties will be applied as detailed in SR20(h).
- 29. Competitors will be required to complete a declaration regarding the use of Navigational Aids as part of the event entry form, confirming they understand the following regulations and the associated penalties for breach of this regulation. 'Using any global or other positioning device (R18.6.4), any car-driven distance recorder or average speed calculating device of post-1940 design, and/or any digital display clock, calculator or other device which is attached to the car.'
- 30. The Organisers' mileages shall be deemed correct and are not subject to protests.
- 31. Force Majeure notwithstanding, the Organisers reserve the right to delete penalties at any control or check and/or delete any part of the route from the results if they deem it fairer to do so.
- 32. Any notice displayed at the start or en-route bearing an official's signature shall have the same authority as these SR's.
- 33. Any appeal or protest must be lodged in accordance with C5 & C6.
