Supplementary Regulations

This event is Held under the General Regulations of Motorsport UK (Incorporating the provisions of the International Sporting Code of the FIA) and the Supplementary Regulations.

- 1. The Vintage Sports-Car Club Ltd will promote a Concours D'Elegance at the Oulton Park Circuit, nr Tarporley, Cheshire on Saturday 10 July 2021.
- 2. A Certificate of Exemption has been obtained from Motorsport UK.
- 3. Only fully paid up members of the Vintage Sports-Car Club will be eligible to enter. Such members may enter more than one car.
- 4. All entrants must complete and sign the official entry form and return it to the VSCC office.
- There will be a Concours D'Elegance with the Cheshire Life Trophy going to the winner. Any named trophy will be retained for a nominal period of twelve months. Awards will also be presented to 2nd and 3rd places.
- 6. All drivers and passengers must sign-on. Time permitting there will be a parade lap at luchtime.
- 7. The local team of judges led by Dave Moroney are appointed Judges of Fact for the purpose of deciding the relative standards of the entries. No protests will be entertained.
- 8. Any car entered must be Pre-1941.
- 9. The entry list opens on publication of these regulations, and closes finally on 4 July 2021. Late entries may be accepted at the discretion of the organisers. **The entry fee is £25**, which includes two admission tickets and a programme. In the event of event cancellation or withdrawal no refunds will be available. Entries must be made on the official entry form and accompanied by the appropriate fee. Cheques must be made payable to the Vintage Sports-Car Club Ltd. Entries will be acknowledged by return.
