GENERAL REGULATIONS



Held under the General Regulations of Motorsport UK (incorporating the provisions of the International Sporting Code of the FIA) and these Supplementary Regulations.

1. All events are open to all fully elected members of the organising Club, and where advised in the Supplementary Regulations, invited Motorsport UK Registered Car Clubs. The Driver will be deemed to be the entrant in all instances, except where they have not reached their 18th birthday (H27.1.7 – H27.1.8).
2. All competitors and Drivers must produce a valid Club membership card. All competitors and Drivers must produce a valid MSUK licence (either an RS Clubmans/Speed/ Race/Rally) You are asked to note H12.1.6 (a sealed envelope for the sole use of the Chief Medical Officer is recommended). Medical information forms will be sent out with Competitors instructions for Competitors to note any medical conditions.
3. TRIAL CHAMPIONSHIP
Due to the changing Covid situation there will not be a 2020/21 championship.
4. The events will consist of the following classes: -
Class 1 Short wheelbase cars (less than 8' 6" & HRGs) and cars with solid rear axles – sub divided as follows:
1a. Standard cars
1b. Modified and Special cars
Class 2 Long wheelbase cars (8' 6" and over). ALL cars must have an operational differential – sub divided as follows:
2a. Standard cars
2b. Modified and Special cars
Note: The above as defined by the Eligibility 2018 Rules. The organisers reserve the right to reclassify cars at their discretion.
No car will be accepted without an up-to-date, current VSCC Eligibility 2018 Document (*Buff Form*) issued in the name of the current owner and the number must be quoted on the entry form before the entry will be accepted. The entrant must bring the Cars Eligibility Passport (*Buff form*) to the event. All vehicles must comply with the Motorsport UK Technical Regulations and with the VSCC's 'Eligibility of Cars 2018' leaflet (Edition 5). The organisers reserve the right to exclude any car that are considered to be unroadworthy. It is the competitor's responsibility to present the Car in a fully roadworthy condition and properly equipped to take part in AND THROUGHOUT the event.

The following Motorsport UK Regulations are stressed or modified as appropriate:
H28.1 (ADVERTISING) No competing car may carry advertising unless authorised in advance by the organisers.
H32.1.5 (ROADWORTHINESS) An entrant shall, before the event, satisfy themselves as to the eligibility and safety of the vehicle, safety equipment and competence of its Driver.
H32.1.6 (ROADWORTHINESS) An entrant shall furthermore ensure that a vehicle is maintained in an eligible and safe condition throughout the event or meeting.
H32.1.7 (ROADWORTHINESS) The act of presenting a vehicle and safety equipment for official scrutiny shall be deemed a declaration of its fitness and eligibility for the event and an acceptance of the consequences of such a declaration not being valid.
J5.1.4.1 (WET BATTERIES) Have any wet batteries in Driver/passenger compartment in a securely located leak-proof container. If located in the Driver/Passenger compartment (*including under the seat*), where a Passenger/Co-Driver is present, the battery must be situated behind the base of the Driver or Co-Driver/Passenger seat. Any wet batteries in passenger compartment (*including under the seat*), must be enclosed in a leak proof container (*in the event of the battery being damaged and the car rolls over, this will stop battery acid leaking onto the occupants.*) Fully wrapping the battery in heavy duty plastic is an acceptable leak proof container.
J5.2.1.4 On-Board Cameras. **Where cameras are permitted but not mandated by the organiser, they may be mounted in any location on the vehicle which is considered safe by the Chief Scrutineer. The use or otherwise will be specified in the event Regulations (Competitors are asked to think about the footage before it is up loaded to any social media) Competitors are reminded that the use of handheld cameras whilst attempting a section is strictly prohibited.**
T1.3.24 (SPILL KITS) It is mandatory for all competitors to carry a (*Motorsport UK approved*) small spill kit. This kit must consist of absorbent pads and/or granular absorbent material capable of dealing with spillages up to 1.25 litres capacity. These must be carried throughout the event.
T4.1.1 (CREW) The passenger seat alongside the Driver must be occupied at all times, the passenger may 'bounce' from the seated position only.
T4.1.1.1 ('BOUNCING') Will be permitted only within the confines of the seating compartment, and then only so long as no portion of either the Driver's or Passengers' body, other than arms and hands, are placed outside the sides of the car or behind the seat they are occupying.
T4.1.3. (Driver) In Car Trials, entries may be accepted from Drivers aged 14, 15 or 16, or from Drivers of 17 or over who do not hold a full RTA Licence. In such cases the Driver must be accompanied by a Passenger who holds a full RTA Licence and is experienced as a Driver of Car Trials or Sporting Trials.
T4.1.5.(Crew) Minimum Passenger ages are as follows:
T4.1.7 (Crew) Additionally the rear seats of saloon cars can be occupied by the number of people for whom they were designed. Passengers who occupy the rear seats of the vehicle must not be less than 2 years of age, any child under 12 years of age or 135cm in height must be seated using an approved 'child restraint'.
T7.3.3 (SCORECARDS) Instructions as to the time and location for Scorecards to be handed in will be advised in the Competitors Instructions.
T9.4 – T9.5.1 (DIFFERENTIALS) Competitors are required to complete a declaration in relation to differentials as part of the event entry form. Any entry received with this section incomplete will not be accepted. This Regulation will be enforced.
T10.7 (BRAKES) Fiddle brakes are not permitted.
5. Awards will be presented as per the event Supplementary regulations including: First, Second and Third class awards as appropriate to the number of starters in each class.
6. Provisional results will be published as soon as possible after the end of the event, and a copy will be dispatched in writing by post or email within seven days of the event (ref **D26.1.3**).
7. Any appeal or protest must be lodged in accordance with **C5, C6** and **C7**.
8. Starting numbers will be as shown on the list of entrants; Class 1 cars will be numbered upwards from 100; Class 2 cars from 200. Unless specified otherwise in the individual event Supplementary Regulations.
Numbers identifying the competitor will be provided by the organisers **T5.1.1**.



9. Marking and penalties will be as printed in the appropriate section of the Motorsport UK General Regulations; The method of recording scores will be as follows: wherever you stop on the hill, the Marshal nearest to that point will ensure your card will be marked correctly with the score and initialled. Front wheel hub marking will be used and competitors will be credited with the appropriate marks for the part of the section reached by the centre of the front wheel. A car will be deemed to have stopped when the un-driven wheels cease to revolve, when it fails to leave a start or restart, or when it touches a marker of any kind, or all four wheels have left the course (four wheels out) The point of failure will be considered to be that at which any marker is first struck. For clarification purposes, FO illustrates what that car has scored. Car 3 has passed the twenty marker with the centre of the nearside hub but has hit the nineteen marker, so scores 18.



To avoid any misunderstanding Motorsport UK Rule T6.4 is quoted in full;

6.4. A competitor will also be considered to have failed to negotiate an observed section non-stop if

6.4.1 Any part of their vehicle or its occupants touch a marker

6.4.2 All four wheels are positioned outside of the boundary of the course at the same time. The boundary is represented by a straight line drawn from course marker to course marker along the direction of the course.

6.4.3 The point of failure will be considered to be that at which any marker is first struck, or the point at which the boundary of the course is first crossed by all wheels of the competing vehicle.

6.4.4 Should this point of failure coincide with the division between two sub-sections, the marks lost will be those appropriate to failure in whichever of the two sub-sections provides the greater penalty.

The organisers reserve the right to include any of the following: -

Stop/restart tests and/or different start lines and/or route variations for different Classes. Stop/restart tests maybe either mandatory or optional, these will be clearly stated in the event Competitors instructions.

11. STOP & RESTART PROCEDURE [NOTE: stop/restart may not apply to all classes The start line Marshal will brief the driver

- I. On the approach of the competing car, the flag Marshal will hold his flag out **steady**, in good view and near the restart line, which will be marked by **STOP** signs.
- II. When the flag Marshal is satisfied that the car has come to a halt in the **correct** place, he/she will then drop the flag. The dropping of the flag is the signal for the competitor to restart in their own time (please note that starting before the flag drops is a fail).
- III. The **correct** place is astride the **RESTART/STOP** line **and** with the front wheels before the second line, if it exists.
- IV. A certain small amount of rolling back is acceptable, **AS LONG AS** both front wheels remain **beyond** [ie. Above] the restart/stop line.

12. Entries

- i. The entry list opens approximately two months before and closes two weeks before.
 - ii. Entries may be made online or sent by post using the official entry form and accompanied by the entry fee. Received entries will be acknowledged on receipt (D16.1). Any entrant not receiving an acknowledgement within reasonable postal transit time of posting their entry should contact the Secretary of the Meeting at once.
 - iii. Entries will be accepted on a first come first served basis for the first 80%, with the remaining 20% selected at the discretion of the organisers (H30.1.2 – H30.1.3) and in accordance with the Clubs published guidelines – acceptance/rejection will be notified after the closing date.
(This percentage may vary but will be outlined in the Event supplementary Regulations)
 - iv. Entry fees may be refunded if cancelled by the competitor before the Competitors` Instructions are issued in accordance with the Clubs published guidelines.
 - v. In the event of cancellation of a Trial competitors may be charged an administration fee to cover costs already incurred.
13. Results will be published in accordance with D26.1.2 at the end of the meeting, declared as Provisional for seven days before being declared as Final.
14. All competing cars must have a 'top dead centre' marked on the steering wheel.
15. All competing cars must carry a primed and serviceable Fire Extinguisher THROUGHOUT THE EVENT. A minimum of 1.75 litres of AFFF in one Extinguisher or other FIA/ Motorsport UK approved system. Fire extinguishers must be securely attached and accessible to the Driver.
Fire extinguishers need to be serviced every twenty four months, If your extinguisher has a production date on it that is less than twenty four months from that date it is acceptable, if not the extinguisher will need a service sticker. See 10 Xii.
HIGH PRESSURE GAS BOTTLES ON TRIALS – All trials: The carriage of high pressure gas cylinders on VSCC trials cars is prohibited.
Commercially available aerosol devices are permissible but any cylinder normally subject to specific maintenance procedures will not be allowed.
16. Fuel cans must be securely attached to the vehicle. This also applies to other heavy items such jacks/pumps etc.
17. Any appeal or protest must be lodged in accordance with C5 and C6.
18. All competitors should read the Official Notice Board when they Sign On to check for any amendments/changes.
19. Events are routed along and/or across public rights of way. Competitors must exercise caution and reduce their speed accordingly near other path users. Be especially careful near horses. Slow down, stop and switch off your engine if necessary.
20. A self-declaration form will be issued and Competitors must return it to the office before the event say that their car is compliant against this list; (Scrutineers will be at the event doing spot checks and you are required to help them)

22. TRIALS WHEELS AND TYRES

Well-based tyres on the driven wheels must have a tread pattern such that the blocks are not more than 10mm deep, nor more than 10mm apart laterally or circumferentially. There must not be an uninterrupted lateral gap between the side blocks. A minimum tyre pressure rule will be applied. i.e. 7psi for all cars. Off road, Trial and Enduro tyres are not eligible. Adhesives may be used to secure tyres to wheel rims. All other run flat systems and methods of securing tyres to wheel rim are prohibited.

The Trials Sub-Committee has considered the trend on wheels and tyres, particularly the use of wide wheels. It has been decided to limit rim section increase to 1/2". The limits are quoted in the current Eligibility of Cars Document Edition 5 2018 for modified cars.

The list of eligible tyres has not changed

23. Crews can only be changed if approved by the Secretary of the Meeting

Individual Third Party Car Insurance

Competitors are reminded to check their motor insurance policy to make sure that it covers them when on the public road transiting between the sections as many policies have exclusions when the individual is involved in any form of motorsports.

Where the policy cannot be extended to provide the necessary cover the Club has applied to REIS for a Blanket Cover Note under the **Motor Sports Road Traffic Scheme**. This provides Competitors who need to use the Scheme with the Third Party Cover necessary to meet the RTA requirements on the Road Sections of the Event. The rate for each Event is £30.00. New applicants wishing to use the Scheme must be able to comply with all points of the REIS Declaration and these are:-

- Aged 19 years or over**
- Has held a full licence for a minimum of 6 months**
- Has no more than 6 points of their licence**
- Has had no more than 1 fault claim in the last 3 years**
- Anyone aged less than 19 years old will also be accepted at the same price should their co-driver be a more senior member of their family or over 25.**

If you comply with all of the above points and wish to take out the cover then please complete the REIS Competitor Form attached to these instructions and present it when Signing-on for the event and pay the premium to obtain Insurance under this scheme – No Letter of Acceptance will be issued.

Anyone falling outside these limits and not covered by their own motor insurance policy should refer directly to the REIS Motorsport Team on 0115 9651030 at least one working day prior to the event commencing – only in extreme conditions will REIS refuse insurance or a load premium.

SAFETY, HEALTH, ENVIRONMENT AND FIRE (SHEF) AT THE VINTAGE SPORTS-CAR CLUB (VSCC) AND DURING VSCC EVENTS

It is the Policy of the Vintage Sports-Car Club (the Club) to operate in a positive culture of safety, health, and environmental protection throughout its entire business and sporting activities. To this end, the Club will coordinate all relevant activities under the collective heading of Safety, Health, Environment and Fire, or 'SHEF'.

The Club fully recognises the potential risks in its activities, the application of relevant legislation, and that it has the ultimate legal responsibility in these matters both in the workplace and at the Club's events. Accordingly, the President accepts overall responsibility for policy formulation and effective implementation of that policy. In turn, all employees, competitors, officials, and volunteer helpers are responsible for all SHEF duties allocated to them, either directly, or as a result of the Club's SHEF policy. Members of the public at Club events, whether paying or not, will be advised of their responsibilities as a result of their decision to spectate.

In pursuance of this policy, the Club will progressively identify all hazards and take measures to reduce risk. Motor Sport is spectacular and exciting, providing enjoyment to competitors and spectators alike, but there are many aspects of the sport which carry inherent risk. Much of this risk cannot be eliminated totally, and the emphasis must therefore be placed on controlling the risk through effective risk management systems. The purpose of such Risk Management will be elimination of the risk where possible, or to reduce the risk to levels which are demonstrably As Low As Reasonably Practicable (ALARP) where it cannot. Throughout all of its activities, the Club will appoint an appropriate number of competent persons to implement the Club's SHEF procedures. In addition, a number of SHEF committees are established to ensure proper consideration of all risk factors, Committee members and other competent persons may be employees or volunteers. Competence will be guaranteed by formal training, the maintenance of records and, for motor sports events, full compliance with the rules and regulations of The Motor Sports Association (MOTORSPORT UK), the governing body of the sport in the UK, and the venue owners.

Supplementary Regulations

In 2021 the Herefordshire Trial will be two separate trials, one on Saturday and one on Sunday with reduced number of entries and hills on each day. Reducing the need to stay overnight, the start will be later in the morning to allow Marshals and entrants to travel to the trial, with it being April light at the end of the day will not be an issue. If you would like to enter you will need to enter either for Saturday or Sunday. Once we have closed entries there might be space available and we will endeavour to fill up those spaces. To be able to do this we will need those who would like to enter on both days to submit entries for both Saturday and Sunday (still indicating your preferred day, or if you are flexible) if there are spaces available, we will then use this information to fill up the entry list. Trailer parking will be available at How Caple Court.

1. The Vintage Sports-Car Club will organise a Clubmans permit Car Trial on 25th April based at How Caple Court, Herefordshire, HRI 4SX (OS Map 149/612306)
2. **Covid 19.** Changes have been made to the VSCC's usual practice of running a Trial to follow government and MSUK's guidance.
 - I. After entries have closed Competitors will receive an emailed declaration form which includes signing on, self-scrutineering and Covid-19 health statements, plus names and details of all crew members and emergency contact details etc. Click here [My Passenger details as required for the signing on process \(vsc.co.uk\)](https://www.vsc.co.uk)
The completed declaration MUST be returned to the Secretary of the Meeting prior to the event. This form is mandatory – NO form NO start.
 - II. Sticky numbers and scorecards which will be posted out upon completion of all the digital declarations before the event.
 - III. At each hill, marshals will record the score on their master score sheet, which will be used to work out results. These scores will be communicated to the driver who can note them on their score cards.
 - IV. Upon completion the Competitor should inform an official they have finished.
 - V. **Accident declaration will be in reply to email sent out by the Club office to all Competitors after the event.**
 - VI. A scrutineer may inspect random cars throughout the competition.
 - VII. Advice from UK Government, Motorsport UK and Public Health England/NHS will be monitored prior to the event. Expect changes to the event organisation and format because of newer or more recent MSUK & Government announcements.
 - VIII. Use a face covering at the event. There is now the requirement for all Event participants to wear a face covering in areas where 2m social distancing cannot be maintained. Face coverings must be worn by competitors as they arrive at, during and as they exit the section to protect the Marshals.
 - IX. Extra requirements will be implemented as the organiser see fit to ensure the event is Covid safe.
3. The meeting will be governed by the General Regulations of the Motorsport UK (incorporating the provisions of the International Sporting Code of the FIA), these Supplementary Regulations and any written instructions the organising Club may issue for the event.
4. Motorsport UK permit number - 119914 Event number-28463AP24/25
5. The event is only open to all elected members of the organising Club. All drivers must produce a valid club membership card and have paid their 2021 subscription.
6. The programme of the meeting will be:
Sunday 25th April 2021
1100hrs Hills Open
1630hrs Sections Close
1200hrs Any competitor not at their start hill by this time may be excluded.
7. Competitors will require OS Landranger Maps 149 & 162 (an extract of 162 will be provided in the Competitors' Instructions)
8. Public roads will be used to link observed sections. There will hopefully be at least 7 sections on private land and public by-ways. The entry will be split into groups with different start hills.
9. The event will consist of four classes as follows:
Class 1: Short wheelbase cars (less than 8' 6" & HRGs), cars with solid rear axles. Sub-divided as follows:
 - Ia. Standard cars
 - Ib. Modified, and Special cars

Class 2: Long Wheelbase cars (8' 6" and over). ALL cars must have an operative differential.

Sub-divided as follows:

- 2a. Standard cars
- 2b. Modified and Special cars

10. Awards will be presented at the event as follows:

The Herefordshire Award Sunday for the best performance in any class.

The Andrew Blakeney-Edwards Award Sunday for the best performance in the opposite class

The Moffatt Mug for the best performance in Class 1 will be awarded for retention.

The David Lee Trophy to be awarded at the organisers discretion to the "Competitor of whatever age, who is the most deserving of Special Recognition on either Saturday or Sunday"

First, second and third class awards as appropriate to the number of starters in each class.

11. The entry list opens on publication of these regulations and closes finally on 12th April 2021 (entries received after this date but before 20 April 2021 will be charged at the higher rate £115). The entry fee is £105.00. All entries must be made on the official entry form and accompanied by the appropriate fee. Cheques to be made payable to the VSCC Ltd and sent to VSCC Office, The Old Post Office, West Street, Chipping Norton, Oxon. OX7 5EL.

12. The maximum entry for the meeting is 55; the minimum is 25; the minimum for each class is 10. Should any of the above minimum figures not be reached, the organisers have the right to either cancel the meeting or amalgamate classes as necessary. **To enable us to get as many Members as possible to have a day's trialling. Entries on Sunday will not be Confirmed in the normal way. (if needed please contact the secretary for clarification).** Therefore, entries will not be accepted on a first-come-first served basis for the first 80%, with the final 20% selected in accordance with the VSCC Selection Policy. Entry fees may be refunded if entry is cancelled before the closing date. Entries will be acknowledged on receipt. Any entrant not receiving an acknowledgement within reasonable time of posting his entry should contact the Secretary to the Meeting.

RS Clubman Competition Licenses (unless you have a Race or Speed licence for 2021) these are free, mandatory and issued by our governing body. You can apply online at <https://rsclubman.motorsportuk.org/> and we recommend you and your passengers / navigators do so immediately. If you wish to apply using a paper form or are under 18 you can download the form [RS CLUBMAN FORM.pdf](#), and return by post to Motorsport UK **Under 18's. Navigators and Passengers under the age of 18 do not require RS Clubmans licenses.**

15. Marking and penalties will be as printed in the appropriate section of the Motorsport UK General Regulations and VSCC Trials regulations 2019/20 except as modified below:

Option 1 If you decide to ATTEMPT the traditional STOP/RESTART having told the start Marshal, STOP with front wheels in the box at the STOP/RESTART A SMALL AMOUNT OF ROLLING BACK IS ACCEPTABLE (YOU MUST NOT ROLL OUT OF THE BOX) after the marshal indicates you may do so, should you then to go on to clear the hill you will be awarded a 10 point bonus, giving a total of 35 points for the hill. Worth a gamble? Should you fail at the Stop/Restart, or anywhere else on the hill for that matter, you will receive the score indicated by the marker you have reached in the normal manner. Option 2 If you decide NOT TO ATTEMPT the traditional STOP/RESTART. In this case you will start the Section, DRIVE STRAIGHT THROUGH THE STOP/RESTART and should you then to go on to clear the hill you will be awarded a total of 25 points for the hill. Should you fail anywhere on the hill, you will receive the score indicated by the marker you have reached in the normal manner. Do not forget you must make your choice before you attempt the Section. You are allowed to walk the hill and a map will be displayed at the Start. |
| ii. | Timed Tie Breaker: Part of Dean's Place Hill Section will be timed and will act as the tie break. It is RECOMMENDED that you WALK the HILL. When you arrive at the Hill the marshal will remind you that there will be a timed element. You start the Hill when the start marshal gives the OK. Part way up there will be a Stop/Restart.
